Service category definition

Oral health services are intended to help people living with HIV access services such as outpatient diagnosis, prevention, and therapy provided by dental health care professionals, including general dental practitioners, dental specialists, dental hygienists, and licensed dental assistants. The Ryan White Part B Program (RWB) contracts with a dental insurance plan association for administration.
