3rd Dose/Booster Dose Information

Under the FDA emergency use authorization and ACIP recommendations, Pfizer-BioNTech (Comirnaty) booster doses are authorized for:

- people who are 65 and older, and
- people who live in a long-term care facility, and
- people 18 and older with underlying medical conditions that put them at high risk for severe illness from COVID-19.
- people who live or work in a setting that puts them at a higher risk of exposure to COVID-19, such as healthcare workers and teachers (this was overturned by the CDC Director after the ACIP voted against this measure).
